

Veterinary Feed Directive (VFD) Update

1. Clients must have a Veterinary Client Patient Relationship (VCPR). This means that depending on the size of the farm, a veterinarian must visit the farm at least once annually.
2. There will be two categories of drugs:
 - a. Category 1 – requires no withdrawal at the lowest level of use
 - b. Category 2 – require a withdrawal
3. VFDs will apply for 6 months at most and some may expire sooner
4. If a VFD drug is approved for use at multiple drug concentrations, a single VFD can be issued that approves multiple drug levels.
5. VFDs must be written and cannot be issued over the phone.
6. VFDs must be retained for 2 years by all parties (the veterinarian, the distributor, and the client)
7. Any drugs that need a VFD cannot be used or fed without authorization from a veterinarian on a VFD order.
